The bids will be evaluated in terms of criteria for evaluation as per CPWD norms (refer Annexure I of Appendix 20 of CPWD works Manual 2014). A bidder who scores minimum 60% marks in each of the categories (A) to (H) individually and scores minimum 70% on overall marks will qualify for Empanelment.

#### 2.0 TERMS AND CONDITIONS

- 2.1 BID document for empanelment shall be submitted in a sealed envelope super scribing thereon "Application for Empanelment of Contractors for Civil works at IASST, PaschimBoragaon, Guwahati-35." and the category of work applied for.
- 2.2 The application shall be submitted strictly in the prescribed format along with supporting documents.
- 2.3 The application shall be signed by the authorized persons on behalf of the applicant organization by enclosing an authority Letter / Power of Attorney.
- 2.4 If the space in the application is insufficient for furnishing full details, the applicant may give the details on a separate sheet.
- 2.5 Application containing false and / or incomplete information is liable for rejection.
- 2.6 If any information or details furnished by applicants are found to be false at any time in future, the empanelment of such applicant will be cancelled immediately.
- 2.7 The Bidder should sign each page of the application.

- 2.8 Overwriting should be avoided. Correction, if any, should be made by neatly crossing out, initialing, dating and rewriting.
- 2.9 IASST may approach / visit the contractor's clients to verify contractor's general reputation / competence.
- 2.10 Documentary proof with respect to the details furnished in the application form regarding eligibility criteria shall be furnished alongwith the application form. With regard to the completed works, copies of the work order and completion certificate shall be submitted.
- 2.11 The applicant has to submit the Client's Certificate as per Annexure-8, from at least two of their clients mentioned in the list of work executed.
- 2.12 Decision of the Director, IASST in selection of of contractors will be final and binding and no further correspondence will be entertained. Contractors empanelled will be informed by post.
- 2.13 The enlistment of a contractor at IASST shall only entitle him to be considered for issue of tender paper. It shall not confer any right on him either to be necessarily issued the tender papers or for award of work.
- 2.14 Generally, the routine works at IASST will be awarded by calling competitive quotations / tenders from the empanelled contractors.
- 2.15 All application must contain recent passport size photo of the contractor or representative of the applicant's assigning him.
- 2.16 The existing empanelled contractor at IASST shall also be required to submit the tender for empanelment.
- 2.17 The existing empanelled contractor at IASST, whose performances were not satisfactory, may not be eligible for empanelment.
- 2.18 IASST reserve the rights to allow Category I empanelled contractor to participate in the job range of Category II.
- 2.19 IASST reserve the rights to float open tender for any job category.
- 2.20 IASST reserve the rights to offload whole or partly of a job if the performance of the contractor is found to be not satisfactory and shall get the job done through another contractor.

# 3.0 **Philosophy of Execution:**

The work is proposed to be executed on competitive bids from the selected list of the empanelled contractors on bid documents of IASST. The contractor will have total responsibility of delivering the products with their expertise on planned execution of the works with mobilization of necessary manpower with plants and machinery required for the specific job to the least botheration and entire satisfaction of IASST.
