Desirable: (i) Qualification in SAS / CA/ ICWA (ii) Experience in working with computers and other advancements in financial management; (iii) Knowledge of Central Government rules, regulations and practices in financial matters Deputation: The candidates holding analogous post or worked in the pay level 10 for at least five years in Accounts Department, possessing SAS/CA/ ICWA qualifications or equivalent with experience in Cash/Accounts/Budget work provided that: The period of deputation shall initially be two years which may be extended for one more year. The total period of deputation in another ex-cadre post held immediately preceding this appointment in the same organization/department shall not exceed five years. The candidate appointed on deputation shall not have any claim for promotion during the period of deputation against ex-cadre post. Maximum Age limit: 55 years on the last date of receiving the application.

Important Notes:

1. Age as prescribed shall be as on the 'closing date for receiving application' (i.e. - 21/01/2021)
2. Age relaxation whenever required will be admissible to the candidates belonging SC/ST/OBC/Physically Challenged/Other Categories as per Govt. of India rules/order on the subject.
3. Candidates already employed must submit their application through proper channel or submit a 'No Objection certificate (NOC)' from their employer. Such candidate may submit an advance copy of their applications online but their candidature shall only be considered if the applicants submit their NOC/receive proper channel application within 10 days after closing date of online application. Those who apply for appointment on deputation should submit the applications along with vigilance/integrity certificates and attested copies of their Annual Performance Appraisal Reports (APAR) for the preceding five years.
4. It may be noted that mere possessing of the prescribed qualifications and requisite experience would not entitle a person to be called for interview. Only the shortlisted candidates will be invited for interview.
5. Canvassing in any form will be a disqualification. Postal delay shall not be entertained.
6. No correspondence will be entertained in respect of advertisement, interview, selection and appointment etc. The candidates are requested to check the IASST website: www.iasst.gov.in for related information from time to time.
