## **General Instructions to the applicants**

- 1.** Only Indian Nationals can apply for the posts.
- 2.** Applicants should read carefully the requisite minimum essential qualifications, age and eligibility, experience criteria etc. laid down in the Advertisement before applying for the post.
- 3.** The maximum age limit and eligibility conditions shall be reckoned for the post(s) as on the last date of submission of online applications fixed.
- 4.** Candidates must apply online on prescribed application form at IASST Website along with on line submission of all scan copies of the educational certificates, experience certificate etc.
- 5.** An Application Fee of Rs 500/- (Rupees five hundred) only has to be paid through bank draft/bankers cheque drawn in favour of “Director IASST” payable at Guwahati. The fee once paid will not be refunded or re-adjusted under any circumstances. No fee is required for SC/ST, PWD category of candidate. Candidate after submission of the online Application along with scan copies of all required certificate/testimonials/documents a PDF will be generated with the completed form. Applicants are required to print hardcopy of application form sign and send the same along with all self-attested relevant supporting documents and application fee within the prescribed date to the Registrar, IASST, Guwahati-35.
- 6.** Application once submitted cannot be altered under any circumstances. However, if the candidate wishes to reapply by paying necessary fee again he/she may do so within the last date of submission of application. Further, no request with respect to making changes in any data/particulars entered by the candidate in the online application shall be entertained once the application is submitted successfully. Therefore, please keep all data/details ready before you start filling up the online application.
- 7.** Before submission of the online form the candidates must satisfy themselves of the suitability for the position to which they are applying. If at any stage during the recruitment and selection process, it is found that candidates have furnished false or wrong information, their candidature will be summarily rejected at any stage of recruitment process or during the service period.
- 8.** Incomplete applications and those without relevant supporting documents (self-attested copies of Date of birth/Degrees/Certificates/Mark sheets/Experience Certificates/caste certificates, and other required Documents, etc.) shall be summarily rejected. Hard copies of the applications submitted without applying online will not be accepted.
- 9.** Only short listed candidates will be called for written test/skill test/ interview. Mere fulfilment of minimum qualifications and experience does not entitle any candidate to receive call letter.
- 10.** The applicant serving in Govt./Semi-Govt./PSUs/Autonomous organization must submit their application through proper channel /submit No Objection certificate. Such candidate may submit an advance copy of their applications online but their candidature shall only be considered if the applicants submit their NOC/receive proper channel application within 10 days after closing date of online applications.
- 11.** No TA and accommodation shall be provided for attending the written test/skill test/interview
- 12.** The Institute reserves the right to hold a written test/skill test for selection of candidate(s) for the advertised post(s).

- 13.** Candidates are advised to visit the Website: [www.iasst.gov.in](http://www.iasst.gov.in) regularly to update themselves. Only e-mail communication will be sent for calling for interview. No separate call letter will be sent.
- 14.** A Candidate's admission to the Written Test/Skill test (if conducted by the Institute)/or called for interview, and subsequent process is strictly provisional. Mere fact that the call letter(s)/has been issued to the candidate does not imply that his/her candidature has been finally cleared by the institute. The IASST, Guwahati would have right to reject any application, at any stage of the process, cancel the candidature of the candidate in case it is detected at any stage that a candidate does not fulfil the eligibility criteria and/or that he/she has furnished any incorrect/false information/Certificate/documents or has suppressed any material fact(s). If any of these shortcomings is/are detected after appointment in the IASST, Guwahati, their services are liable to be summarily terminated.
- 15.** The institute reserves the right to:
