With reference to the above, the requisite information is furnished as below:

1. No. The Sixth Assam Revision of Pay (APC) Rules come into force in Oct.2009, but IASST was taken over by DST Govt. of India on March 9, 2009. However the Cadre staff were given the financial benefit with retrospective affect w.e.f. 01-01-2006 as per 6th APC pay in the year 2013. Before March 9, 2009, Academic Staff were given UGC pay scales.
2. Till 8th March, 2009 the non-academic employees were given pay scales as per 5th APC and academic staff were given UGC pay scales.
3. Pay fixation has been made from Govt. of Assam Pre-revised scales to 5th CPC (pre-revised) scale. The aforesaid procedure was followed for fixation of pay. UGC pay scales were converted to 6th CPC pay scales.
4. The informations are available in fiduciary relationship which are personal in nature and has no relationship to any public activity or public interest. Hence can't be disclosed.
5. Yes. Original and re-designated designation are provided at Annexure -I. Pay fixation has been made as per corresponding pre-revised pay scales enjoyed before conversion from State Govt. to Central Govt. under DST, Gol, not as per designation.
