Minutes of the Committee for resolving the issue arising out of the orders of the Hon'ble Gauhati High Court on dated 13/12/2021 in Case WP(C) No. 7957/2015 (Smt. Juri Pathak – vs. – The Union of India and Ors.) held on 03/01/2022 at IASST, Guwahati.

#### THE FACT OF THE MATTER:

Ms. Juri Pathak was appointed initially in the post of Instructor in the year 2001 in the scale of pay of Rs.3,760-Rs.9,400/- when IASST was under the Govt. of Assam as an Autonomous Organisation registered under the Societies Registration Act, 1860. The Govt. of India, Deptt. of Science and Technology, Ministry of Science and Technology took over IASST with a condition that the structure of the pay enjoyed by the employees of IASST prior to taken over will continue as it is, in accordance with the 6<sup>th</sup> CPC.

Prior to implementation of the 6<sup>th</sup> Pay Commission of the Govt. of Assam, the pay of Ms. Juri Pathak had been fixed by the IASST vide office order no. IASST/PF/2011-12/9979 – 9983 dated 18/11/2011 at the Band Pay of Rs.11,210/-with GP of Rs.4,200/- (Band Pay with GP: Rs. 15,410/) with effect from 09/03/2009 i.e. the date of taking over of IASST by the Govt. of India.

Subsequently, the Govt. of Assam revised the 6th Assam Pay Commission with retrospective effect from 01.01.2006. Based on the 6th Pay Commission of the Govt. of Assam, her pay was revised with retrospective effect from 01.1.2006 to 08.3.2009. The arrears for the said period were paid by IASST.

As per the 6th Pay Commission of the Assam Govt., her Band Pay was Rs.9,150/- with GP of Rs.4,300/- on 09.3.2009, i.e. the date of taking over of IASST by the Govt. of India.

There was no corresponding Grade Pay of Rs. 4,300/- in Govt. of India (6th CPC) wherein the pay of Ms. Juri Pathak was fixed on 09.03.2009. There is a Grade Pay of Rs.4,200/- and a Grade Pay of Rs.4,600/- in the 6th CPC of Govt. of India. Therefore, IASST has given the benefit by up-grading the Grade Pay of Rs. 4,300/- to Rs. 4,600/- in favour of Ms. Juri Pathak with effect from 09.3.2009.

The prayer of Ms. Juri Pathak before the Hon'ble High Court was to review the impugned Fixation Order bearing Memo No. IASST/PF/2011-12/9979 – 9983 dated 18/11/2011 with a request to refix

her pay w.e.f. 09/03/2009 in the GP of Rs. 4600/- in the revised Pay-Band: 2 of Rs.9300 – Rs.34,800/- as per the Fitment Table S-13 as per the 6<sup>th</sup> CPC, Govt. of India with all consequential benefits including arear monetary benefits. She has claimed for revised Basic Pay of Rs. 18,460/- in PB: 2 of Rs. 9,300-34,800/- +GP: Rs. 4,600/- in S-13 of Table-18 w.e.f. 09.03.2009.

#### **RULE POSITION:**

It was made clear in Rule 2 (ii) of O.M. dated 30<sup>th</sup> August 2008 that the fitment tables provided are to be followed for "Normal replacement scales" and for purpose of fixation in case of the UPGRADED SACLES, the Instructions under Clause (A)(i) and (ii) of Rule 7 of the CCS (RP) Rules, 2008, Notification dated 29<sup>th</sup> August, 2008 read with O.M. F. No. 1/1/2008-IC dated 13.10.2008 of Ministry of Finance, Deptt. of Expenditure, GoI shall have to be followed.

Note 2A to the Explanatory Memorandum below Rule 7 of CCS (RP) Rules, 2008 stipulated that where a post has been upgraded as indicated in Part B or Part C of the First Schedule to these Rules, the fixation of pay in the applicable pay band will be done in the manner prescribed in accordance with Clause (A) (i) and (ii) of Rule 7.

The clarification regarding fixation of pay in the Pay Bands, where Posts have been up-graded vide O.M. F. No. 1/1/2008-IC dated 13<sup>th</sup> October, 2008 of Ministry of Finance, Deptt. of Expenditure is very clear which reads as follows:

"The Pay in the Pay Band will be fixed in accordance with the fitment table of Prerevised Scale. His/her revised pay in the Pay Band will be as per the table corresponding to the Pre-revised Scale. To this, the Grade Pay corresponding to the Up-graded Pay Scale will be added".

Instructions for Fixation of Pay consequent on granting up-graded Grade Pay by the Sixth Central Pay Commission- Anomaly in the instructions issued by the Prasar Bharati Secretariat has been clarified by Ministry of Finance, Deptt. of Expenditure, Govt. of India vide O.M. FTS No. 154226/2015/E-III (A) dated 28/07/2015.

The Illustrative example as cited in Ministry of Finance, Department of Expenditure, Govt. of India, O.M. F. No. 1/1/2008-IC dated 13 October 2008 is very clear in the matter of fixation of pay of up-graded Grade Pay as per the 6<sup>th</sup> Central Pay Commission (CPC), which may refer to.
