Agenda item1: Confirmation of last minutes of Building works Committee meeting held on 30.11.2011

Registrar, IASST read the minutes of the last Building Works Committee Meeting held on 30.11.2011 and informed the House that actions were taken on all the decisions of the last meeting. After discussion, the members accepted and approved the minutes.

Agenda item2: Approval and allotment of the work "Construction of Student cum Scientists' Home at IASST"

Altogether Six Tenders were received from the prequalified contractors. Some of the tenderers have deposited the 50% of the Earnest money in the form of fixed deposit receipt and the balance amount by performance guarantee. The meeting discussed the matter relating to fixed deposit as a mode of earnest money deposit in the tender process and opined that as it is an acceptable form of earnest money deposit as per CPWD Manual (clause 19.4) and the CPWD General Conditions of Contract for Central PWD works, 2010(A Government of India Publication under clause 6(i), hence it is valid and acceptable.

Out of the six tenderers M/s Buildrite Construction, 4/4 Commerce House (GOI Building), A.T. Road, Guwahati-1 stood as first lowest bidder. The meeting approved allotting of the work to M/s Buildrite Construction, 4/4 Commerce House, (Gol Building) A.T. Road, Guwahati-1 and approved for negotiation for rates on internal drainage and Electrical works. The BWC also suggested to take approval from concerned authority before issuing work order.

## Recruitment of Project Engineer and Junior Engineer

The meeting discussed about the essential qualification and experience mentioned in the advertisement for the post of Project engineer and opined that Diploma in Civil Engineering with 10 years experience to be treated as equivalent to B.E. with five years experience as mentioned in the advertisement. After scrutiny all the six applications received for the post of Project Engineer and four applications out of nine applications received for the post of Junior Engineer have been selected to be called for interview
