SECTION 2: ELIGIBILITY CRITERIA

1. The Bidder should be a manufacturer/distributor/authorized dealer/stockiest of the product for which the rate contract is sought for. Distributor/dealer/stockiest should submit the authorization certificate from the manufacturer. If manufacturer and/or authorized dealer submit bid for same product, then such bid will be considered as single bid.
2. The Bidder's Firm should have similar nature of business for minimum period of 5 years. (Copy of Certificate of Incorporation/ Registration Certificate of the Firm to be submitted).
3. Copy of the PAN card GST registration of the firm should be enclosed.
4. Copy of the IEC Code certificate (if applicable) to be enclosed.
5. All the Technical Bid information related to the bidder must be furnished along with the form given in **Annexure-1**.
6. All the Financial Bid information related to the bidder must be furnished along with the form given in **Annexure-2**.
7. The Bidder must not be blacklisted/suspended or should not have any service related dispute with any Organization/ Govt. Organization in India or outside. A declaration to that affect has to be given as per **Annexure-3** in the letterhead of the firm.
8. The Bidder should have rendered similar nature of Rate Contracts services in Govt. Organizations/PSU in the past three years. Copies of such rate contracts must be enclosed.
9. The Annual Average Turnover of the participating firm should be minimum of ₹50 Lacs (Rupees Fifty Lacs only) for last 3 years. (Supporting documents should be submitted).
10. Acceptance of Terms and Conditions as per the format given in **Annexure-4** is mandatory.
11. The bidders should have to give an undertaking to the Director, IASST in the prescribed format given in **Annexure-5**.
12. NSIC/MSME certified agency in the respective field will be exempted as per Govt. rule (supporting documents should be provided).

SECTION 3: INSTRUCTION TO THE BIDDERS

SUBMISSION OF OFFER:

Tenders are invited two bid system (Technical Bid and Financial Bid) from the reputed Manufacturers/Authorized Distributor/Dealer/Stockiest (who have the current authorization from the Principal Company) for entering into Annual Rate Contract for a period of 3 financial years 2023-24, 2024-25 and 2025-26 subject to performance basis for the supply of following products:

Note: Bidders must submit the latest catalogues with rates from the manufacturer on the items for which they are bidding.

SECTION 4: GENERAL TERMS AND CONDITIONS:

- a) There shall NOT be any price component in the submitted technical bid. If for any reason, it is found that the technical bid reveals the price of the product, the bid document shall be summarily rejected in the first instance itself.
- b) The Bidder have to furnish the Financial Bids as per the format given in **Annexure-2**. They are required to quote their catalogue number, name of the product, version and year of manufacturing, where the item is listed, discount offered in percentage as per the catalogue, GST and freight, insurance charges if any. The selected bidders will have to provide soft copy of the latest catalogue price for the item(s) being supplied, soon after receiving the letter of acceptance of rate contract offer.
- c) If financial bid is not quoted as per the format provided in this tender document, IASST will have the right to reject the bid.
- d) Price quoted should be in Indian Rupees only. Price should be for delivery at IASST. Freight, Insurance charges, if any, is to be borne by the Supplier. Similarly, shortage, pilferage, damage if any in transit will be the sole responsibility of the Supplier and the same will be intimated to the Supplier on receipt of goods. The short/defective supply will have to be replaced by the Supplier within 7 (seven) days from the date of delivery without any additional cost including freight/insurance charges. It is mandatory to submit the quotes in the same format as per **Annexure-2** and if some items are not available making it unable to quote, it should be mentioned as NQ (Not Quoted) and the items should not be deleted.
- e) Prices charged for the stores supplied under Rate Contract should under no circumstances be higher than the selling prices of identical description to any other Govt. Organization /Private Organizations during the period of contract failing which may lead to the “**FALL CLAUSE**”. A certificate to this effect may be provided by the firm that the lowest prices have been offered to IASST (as per Annexure IV). In case it is found that the price charged by the firm is more, the same will be recovered from the subsequent/unpaid bill of the supplier and will be forfeited security deposit.
- f) Communication with bidders will be carried out electronically and /or in hard copy. All bidders must provide their current valid email address with documents of address proof.
- g) For the chemicals & reagents to be maintained at cold-chain system with the support of temperature logger tracking throughout the journey time, it is the responsibility of the supplier to supply such item(s) in the respective lab at IASST ensuring the quality of the item.
- h) Overwriting and corrections in the bid documents will not be accepted. The bid documents should be complete in all respects and should duly be signed by the authorized signatory(s) in each and every page with seal. Incomplete and unsigned bids will not be considered. Delayed/ Late bids will not be accepted under any circumstances.
- i) Latest printed price list/Catalogue (Hard Copy) must be furnished in binded form, or soft copy in CD/USB Drive along with the offer. An undertaking may be given that the price list being furnished with the proposal will remain valid during the period of the rate contract.

- j) There will be no change in price structure during the period of contract except of the statutory levies which are made applicable by the Govt. through notifications / regulations.
- k) The selected firm/agency shall submit non-interest bearing performance security of ₹50,000/- (rupees fifty thousand only, in the form of DD/BG/FD), wherever applicable, will be refunded after the expiry of the contract period. In case of Bank Guarantee and Fixed Deposit, the validity of such instrument should be 90 (ninety) days beyond the expiry of rate contract period.
- l) The catalog/printed price list will be revised on yearly basis.
- m) The rate of discount will be revised after 3 years from the date of empanelment.

SECTION 5: CANCELLATION OF THE TENDER:

Notwithstanding anything specified in this tender document the Director, IASST in his sole discretion, unconditionally or without assigning any reason thereof, has the right

- (i) To accept OR reject lowest tender or any other tender or all the tenders.
- (ii) To accept any tender in full or in part.
- (iii) To reject the tender, not conforming to the tender norms.
- (iv) To give purchase preference to Public Sector Undertakings when applicable as per Govt. Policy/Guidelines.

The Rate Contract can be terminated at any time without assigning any reasons by giving one-month prior notice by IASST. Conditional, Unsigned, Late & Delayed tenders will not be considered.

TRANSFER AND SUBLETTING:

The seller shall not sublet, transfer, assign or otherwise part with the acceptance to the tender or any part thereof, either directly or indirectly, without the prior written permission of the Purchaser.

EVALUATION OF OFFER:

1. The final acceptance/decision on the Rate Contract will be taken after screening the offers by a duly constituted committee at IASST which reserves the right to accept/reject the tender wholly or partially without assigning any reasons thereof.
2. The agency/firm/vendor who has quoted the lowest price for a given item will be selected for that product. In case of more than one agency quoting the same lowest price for a product, the Institute reserves the right to place order with the agency who has quoted lowest for maximum number of items.
3. In case the bidder is silent on any clauses mentioned in this tender document, IASST shall construe that the Bidder had accepted the clause as per the invitation to tender. No further claim will be entertained.

SECTION 6: TERMS AND CONDITIONS FOR SELECTED BIDDERS

AWARD OF CONTRACT:

1. A panel of bidders/suppliers shall be selected for rate contract.
2. The empaneled suppliers will abide by all the Terms and Conditions of the tender document.
3. The Rate Contract will be valid for a minimum period of 1 year, which could be extended for a period of another two years on satisfactory performance of the firm/company and on mutual consent on the rates and terms and conditions at the discretion of Director, IASST.
4. The performance of the empaneled supplier's will be reviewed by Committee during contract period and IASST reserves the right to add or delete suppliers in rate contract based on performance if necessary without prior intimation.
5. The IASST reserves the right to enter into parallel Rate Contract for similar items during the period of Rate Contract with one or more parties.

EARNEST MONEY DEPOSIT (EMD):

The Bidder should submit an Earnest Money Deposit (EMD) of Rs.25,000/- (Rupees twenty-five thousand only) in the form of a Demand Draft to be drawn in favour of 'The Director, IASST. EMD of unsuccessful bidders will be returned within 45 days after the award of the contract. The EMD /Security Deposit will not carry any interest.

MSME/NSIC agency will be exempted to submit the EMD as per Govt. Rule.

DELIVERY SCHEDULE:

1. Delivery of ordered items should be made within a period of 2-6 weeks from the date of receipt of the Purchase Order either directly or through dealer (no deviation will be accepted in this regard). Earlier delivery by the supplier is preferred. If the ordered material is not supplied in the above mentioned period, then the IASST reserves the right to cancel the order or not to accept the ordered materials and to impose liquidity damage as applicable as per rule. In case of any urgent requirements, the delivery period may be changed. Partial delivery of ordered items will not be accepted.
2. If the supplier fails to deliver the material within the delivery period as specified, IASST may procure goods or services from other suppliers but the excess cost towards such procurement will be levied on the supplier with whom the rate contract is exit. The supplier will be liable to pay IASST any such excess costs incurred for procurement of goods or services not delivered in time.
3. The items, so supplied will have to be of high quality and grade and in the inspection/test if these are found to be of inferior quality, the same are to be replaced by supplier at their cost within the stipulated period, failing which the Rate Contract of the firm may be cancelled. Delayed supply/non-compliance of complete order may also lead to cancellation of Contract.

LIQUIDITY DAMAGE:

The date of delivery should be strictly adhered to; the IASST reserves the right not to accept the delivery in part or full. The liquidity damage @0.5% per week subject to a maximum of 5% of the ordered value shall be imposed in case of delay in delivery.

TAXES AND DUTIES:

Taxes and duties will be applicable as per prevailing Govt. rate.

PAYMENT TERMS:

The payment for the supply of items will be made to the firm only after receipt and inspection of materials by the IASST Indenter. **No advance payment will be made for the supplies.** No Bill for part delivery will be entertained. No payment will be made for unsatisfactory supply.

WARRANTY: The bidder shall be fully responsible for the manufacturer warranty in respect of quality and workmanship of the materials covered in the Rate Contract. In case of any defects found at the time of use, the supplier will have to provide free replacement or refund the amount charged for that item.

DISPUTES: The dispute(s) if any, arising in relation to the Rate Contract, shall be subject to Guwahati jurisdiction only.
